| Family                | *\$850.00   | Husband/wife and all dependent children. A child is considered dependent until the age of 26 if attending a college or university on a full-time  |
| Single                | *\$565.00   | A single person   |
| Junior Family         | *\$565.00   | A married couple in which both members of the family are under 33 years of age as of May 1 of the golf year.  |
| Limited Family        | *\$565.00   | A married couple in which only one designated family member has golfing privileges. The spouse of the golfing member has a social privilege under this membership.  |
| Junior Limited Family | *\$490.00   | A married couple in which only one designated family member has golfing privileges. The golfing member must be under 33 as of May 1 of the golf year. The spouse of the golfing member has social privileges under this membership. |
| Junior Single         | * \$490.00  | A single person who no longer qualifies for membership as a dependent of a member or who no longer qualifies as a junior member (must be under 33 as of May 1 of the golf year).  |
| Junior                | \$ 260.00   | A person under the age of 26 (as of May 1 of the golf year) who is dependent upon parent(s) who are not golfing members of the club and who is attending high school, college or university on a full-time basis, summers excluded. |
